OCTOBER IS DOMESTIC VIOLENCE AWARENESS MONTH

October is a very busy month for staff at McLeod Alliance. During this month, we focus on outreach and spreading awareness of both domestic violence and our services throughout McLeod County. This is because October is recognized nationwide as **Domestic Violence Awareness** Month (DVAM). This past DVAM 2022, the campaign slogan was Every1KnowsSome1, highlighting the prevalence of relationship violence. The statistics indicate that 1 in 4 women & 1 in 7 men will experience violence from an intimate partner within their lifetime. Just this past fiscal year, the Alliance served 385 victims/survivors in McLeod County. Abuse may be a lot closer to home than many realize. Someone you know may be experiencing relationship abuse- it could be a family member, a neighbor, a coworker, a friend. We know domestic violence does not discriminate, and it can happen to anyone. This is why it is important to let our community know about our services, and that we are here to offer support & resources.

Stalking Survivor Shares Her Story in Observance of January 2023 Stalking Awareness Month

"My Guardian Angels"

My story began 30 plus years ago when a complete stranger approached me at my place of employment and told me he loved me. It made me feel very uneasy.

Then the phone calls started. I told him to stop calling me but he continued. My family, friends, employers and relatives were getting calls, asking about me. It got so bad that I went to the police for help, and that's when I was introduced to my "Guardian Angels", McLeod Alliance. I thought at the time, "how can they help me?" Well, I don't know how I would have handled the situation without them.

Over the years they have been there for every violation, every court hearing, keeping track of all the documentation, but most of all giving me strength and courage when I didn't know I had it. They have helped me file 8 harassment restraining orders, accompanied me to numerous court hearings, helped me write a victim impact statement to present to the court, and so much more.

Eventually I was granted a 50 year harassment restraining order. But that didn't end the cycle. My stalker has as history of alcohol abuse, has had numerous DWI's, and has an extensive history of drug abuse. At one point, there were 75 active harassment restraining order violations. He eventually went to prison for those violations, but somehow was still able to contact me by phone. He even found a way to send me letters from prison. For every violation, my Guardian Angels were there to support and help.

Years ago, my stalker was diagnosed with several disorders and committed to a mental health correctional facility. While he was there, I received a call from the facility that he had threatened my life. He spent many years there and eventually was granted a provisional discharge from civil commitment and was moved to another facility. Recently, I was notified that it has been approved for him to live independently. I contacted my Guardian Angels and once again they are working hard on my behalf to keep me safe. I don't know what I would do without them!

My story is not over and I don't think it will ever end. But I thank God for my Guardian Angels.
